1. Introduction

Each Infrastructure Manager (IM) and – if applicable – Allocation Body (AB) of a corridor publishes its Network Statement (NS) for each timetable year on its website.

2. Objective

The aim of CID Book 2 is to give easy access to all NSs of the IMs/ABs involved in the Corridor in line with Article 18 of the Regulation.

3. NS Excerpts

In order to facilitate the consultation of the NSs for the applicants, an overview of the NS per IM/AB involved in the Corridor and per chapter and sub-chapter is provided in a harmonised table used by all corridors. The structure of the table corresponds to the RNE Network Statement Common Structure. This table includes links that lead to the English versions of the IMs'/ABs' NSs or if not yet available temporarily to the national language version until the English version is available. All the NSs and the NS excerpts published in this Book comprehend the main chapters 1-6, each containing a table with the following information:

1. General information
2. Access conditions
3. Infrastructure
4. Capacity allocation
5. Services
6. Charges
